## **Engineering**

Some conversation on speeds. There was some legislation changes work zone speed management study to regarding work zone speeds.

The language was passed in 1st SS, HF 10 which is under Chapter 5:

- 120.12 Sec. 140. WORK ZONE SPEED MANAGEMENT STUDY.
- 120.13 (a) The commissioners of transportation and public safety must perform a work zone
- 120.14 speed management study. At a minimum, the study must:
- 120.15 (1) evaluate existing legal authority for strategies, practices, and methods to reduce
- 120.16 vehicle speeds and enhance worker safety in work zones, which may include but is not
- 120.17 limited to use of traffic control devices, use of barriers, traffic control design modifications,
- 120.18 and speed enforcement actions;
- 120.19 (2) propose a process for contractors operating in a work zone that allows contractors
- 120.20 to request modifications to a project's traffic control plan, in order to reduce vehicle speeds
- 120.21 or improve worker safety in a work zone;
- 120.22 (3) make recommendations on changes to current policies and procedures related to
- 120.23 work zone safety; and
- 120.24 (4) make recommendations on changes to state law to improve work zone safety.
- 120.25 (b) By February 1, 2022, the commissioners must complete the study and submit it to
- 120.26 the chairs and ranking minority members of the legislative committees with jurisdiction
- 120.27 over transportation policy and finance.
- 120.28 EFFECTIVE DATE. This section is effective the day following final enactment.

Commercial Vehicle Alliance has several nationwide Operation Safe Driver Week is this week. Last year thousands of tickets were issued. Law enforcement officers focus on driver behavior. Do people have ideas how to get involvement from local law enforcement agencies?

CVSA - Operation Safe Driver week happening this week.

### Joe Gustafson

County Safety Road Plans are no longer stalled and are being currently updated. Speed and expedition driving has been a huge issue.

They are working on conducing an enhanced Work Zone speeds check. There would be a system that would use a camera to report speeds to a downstream officer (automated speed enforcement). Also working on changes so cities can set speed limits within 2 miles of a school zone.

Dakota County has some grant money and focusing on speed. Dakota County created a 20 minute video that teaches them several items to be aware of the 15 minute video on DOSCI card.

The bike alliance continues to work on bikes and speed.

## **Scott McConkey**

LELs worked with AAA on the I Got Caught wearing a helmet campaign. They are also working with numerous young law enforcement officers and they are discouraged with internal team members. Remember to thank a cop!

The border to border speed program has been a huge success saturating on duty cops on one day in one corridor. It re-engages officers.

There will be a special edition of 'Snapshots from the Field' that will be dedicated totally to reporting on this B2B event.

# **Scot Edgeworth**

Focusing on rest areas to promote traffic safety outreach. We are using the seat belt convincer at several locations. Working on a research study for school bus stop arm violations. They hope the results

will highlight the huge issue of people driving around stopped school buses. They are taking down the old Safe and Sober signs. They are also working to use messages at state parks.

Working with local agencies on scheduling New TZD equipment at events and county fairs. (Seatbelt Convincer, Seatbelt Persuader and Driving Simulator, etc.) Looking at ways to utilize rest area's in the metro to display safety messages in those facility to those traveling through our state. Working with MnDOT LRRB Research Manager with our Dakota and Ramsey County Stop Arm Violation Subcommittee to develop a need statement to be submitted to identify research needs.

### Tara Helm

Back from MDH. Also continuing on replacing the Safe and Sober signs and using traffic safety items (seat belt convincer, etc.)

The office of State Aid at MnDOT completed developing the County Road Safety Plans for 14 counties. The projects from these safety plans will be ready for this fall's Highway Safety Improvement Program infrastructure projects. We also executed a contract to complete another 17 safety plans in the next 18 months. In the area of pedestrian and child safety, the state aid office has been working on developing Safe Routes To School Engineering Studies for 16 locations across the state, which will be completed

this July. Projects and strategies identified in these studies will be ready for the upcoming Safe routes to school infrastructure solicitations.

State Aid at MnDOT completed the state aid project. They will also be conducting other projects including safe route to school projects. They received \$5 million for traffic safety programs including safe routes to school.
