

2022 crashes preliminary as of 04/14/2023


Minnesota Progression to 225 in 2025




Regional Progress Toward SHSP Goal

Southeast Regional Progression to 225 in 2025



Average annual fatalits and serious injuries in TZD Region





** denotes a percent change greater than the percent change in all fatal and serious injury crashes










Average annual fatal and serious injury crashes in modal focus areas












Complex Environments | Southeast Region



Key Takeaways | Southeast Region

- A. Fatal and serious injury crashes 2020-2022 are slightly above 2017-2019
 - +5% relative to baseline
- B. Crash types greater than baseline and trending up:
 - Impairment, [Unbelted may be rising]
 - Commercial Vehicle, Motorcycle, Pedestrian
 - Older Drivers
 - Work Zones
- C. Unlike the statewide shift toward local system, in Southeast rise on Trunk Highways
