#### **QUARTERLY TIM STRATEGY:**

# Quick Clearance:

Quick Clearance is an important strategy for responder safety. When possible, move vehicles off the highway or main road. Utilize crash investigation sites when possible. Strategies include:

- Push Bumpers to clear lanes
- Allow vehicle to drive off mainline

#### **QUARTERLY TIM TACTIC:**

# Early Warning:

Setting up scenes appropriately is critical to the safety of responders. When quick clearance is not an option, early warning should be utilized. Tactics include:

- Cones and Flares
- Direct Messaging Boards
- Extra responders for pre-warning

#### Responder Struck-by Events

The 2023-2024 winter produced warmer than average temperatures, with less snow than the previous year. Despite warmer than average temperatures, several incidents of responders struck roadside still occurred during the winter months

- Situational awareness
- High visibility wear
- Safe responder vehicle positioning

# Oklahoma trooper hit, thrown in traffic stop as vehicle crashes into parked car.

A trooper with the Oklahoma Highway Patrol was involved in a major accident when a vehicle struck a car during a traffic stop near Interstate-40. The Oklahoma Highway Patrol, in a post on Facebook, said that Trooper Jesse Gregory was speaking to a driver during a traffic stop last Thursday when another vehicle hit them.

Dashcam footage from the incident shows the trooper conducting a traffic stop when another vehicle comes from behind and smashes into the stationary car throwing the officer onto the grass way on the side. Both vehicles were also heavily damaged. Fortunately, all three people in the accident, including Trooper Gregory, survived and are expected to be okay. They were all "treated and released," said the highway department. It is not yet clear if the vehicle that crashed was over speeding.

The Oklahoma Highway Patrol said that they posted the graphic video to remind the public of "distracted or impaired driving and the importance of the slowdown, move over law". "We are in the middle of a distracted driving emphasis right now in honor of Trooper Nicholas Dees, who lost his life in the line of duty after being struck by a distracted driver," said the highway patrol.



## Mini Electronic After Action Reviews:

Attached to the last page is a Mini E-AAR from March 3<sup>rd</sup>, 2024. A vehicle crashed into the guardrail on northbound I-35W in Minneapolis. Responders were able to clear the entire event in 34 minutes (responder exposure for only 31 minutes). Tow operators responded quickly, effectively removing the vehicle from a tangled guardrail exceptionally fast. Troopers and FIRST units on scene set up early warning, managing traffic back up. All responders worked to meet goals related to responder safety. See full report on the last page.

**Responder Safety** is a primary goal for the Traffic Incident Management program. Strategies and tactics for preventing emergency responder exposure is critically important when trying to keep responders safe while working roadside incidents. See the attachment below for details of the event.



Traffic incident management, or TIM, is a coordinated effort by all responders to accommodate their safety, victims' safety, incoming traffic's safety, and overall mobility.

Responders include those working in communications, emergency medical services, fire and rescue, law enforcement, towing and recovery, and transportation and public works.
